

# OFFICIAL RULES

## 2025 WIN A CHEVY SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.** THE 2025 WIN A CHEVY SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 10:00 A.M. CENTRAL TIME ("CT") ON JANUARY 2, 2025, AND ENDS ON DECEMBER 31, 2025, AT 11:59 P.M., CT (THE "PROMOTIONAL PERIOD"). ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

**ELIGIBILITY:** THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE STATES OF KENTUCKY, ILLINOIS, INDIANA, IOWA, MICHIGAN, MINNESOTA, MONTANA, NEBRASKA, NORTH DAKOTA, OHIO, PENNSYLVANIA, SOUTH DAKOTA, WEST VIRGINIA, WISCONSIN, AND WYOMING WHO LEGALLY RESIDE IN ONE OF THE COUNTIES LISTED IN THE CHART BELOW AND WHO ARE 21 YEARS OF AGE OR OF THE AGE OF MAJORITY IN THEIR STATE OF RESIDENCE, WHICHEVER IS OLDER, WITH A VALID DRIVER'S LICENSE AT TIME OF ENTRY ("ENTRANT"). ALL OTHERS ARE INELIGIBLE TO ENTER AND WILL BE DISQUALIFIED. VOID WHERE PROHIBITED OR RESTRICTED. Employees of General Motors LLC ("Sponsor"), EventLink LLC ("Administrator"), Jack Morton Worldwide, all participating Chevrolet Local Marketing Associations (LMAs) that are incorporated within the states of eligibility and all their enrolled dealers, all their respective parents, affiliates, subsidiaries, dealerships, distributors, and their advertising and promotion agencies and the members of their immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household with such individuals (whether related or not) are not eligible to enter or win.
