

## OFFICIAL RULES HYUNDAI GRAND SLAM GIVEAWAY

**PROMOTIONAL PERIOD:** The Sweepstakes promotional period begins at 12:00 AM Eastern Time (ET), on March 20, 2026, and ends on the earlier of: (i) immediately following the final out of the bottom of the third inning of the Cleveland Guardians baseball game currently scheduled for September 27, 2026, as such date may change due to the Cleveland Guardians schedule, or (ii) when all available prizes have been awarded (the "**Promotional Period**"). Start times are subject to change due to the Cleveland Guardians schedule.

**HOW TO ENTER:** There are two (2) ways to enter the Sweepstakes during the Promotional Period, each with an equal chance of winning: (1) on-site at select Cleveland Guardians Home Games or (2) online via the website [www.HyundaiGrandSlam.com](http://www.HyundaiGrandSlam.com) (the "**Website**"). No other method of entry will be accepted. The Released Parties are not responsible for lost, late, illegible, stolen, incomplete, invalid or unintelligible entries. Proof of submission will not be deemed to be proof of receipt by Sponsor and/or Administrator.

The Display Area will be open on Entry Game days approximately two hours before the first pitch at each of the Entry Games and will close after the final out of the bottom of the second inning (the "**Open Hours**"). To enter the Sweepstakes, visit the Display Area during Open Hours at any of the above Entry Games, and complete a Sweepstakes entry form by filling out your first name, last name, mailing address, email, phone, age, and any other requested information or scan the available QR Code and enter via the Sweepstakes Website. Entrant must also provide their vehicle of interest, purchase horizon, and if the Entrant owns a vehicle ("**On-site Entry(ies)**"). Online Entries and On-Site Entries are collectively referred to as "**Entry**" or "**Entries**" herein. Entries must contain all information requested and comply with any and all applicable restrictions or requirements set forth herein to be valid. Entries must be submitted and recorded prior to a drawing to be eligible for any given drawing.

**PRIZE SELECTION AND NOTIFICATION:** The process for awarding prizes in this Sweepstakes is outlined below. The Cleveland Guardians 2026 regular season games that occur during the Promotional Period shall be referred to hereafter individually as a "**Game**" and collectively as "**Games**." For purposes of prize selection, a 'Game' means any Cleveland Guardians regular season game (home or away) occurring during the Promotional Period and is not limited to Entry Games at which a Display Area is present.

- **GRAND PRIZE SELECTION AND NOTIFICATION:** Winners need not be present at any Game to win. The Grand Prize will only be awarded if a Cleveland Guardians player hits a Grand Slam Home Run (defined below) during the third inning of a Game. Before the third inning of each Game, the Administrator will randomly select one Entrant from eligible Entries. If a Cleveland Guardians player hits a Grand Slam Home Run during the third inning of the Game, the potential winner will be announced in-stadium and notified via email/telephone (at Administrator's discretion). No winner will be declared if no Grand Slam Home Run is hit by a Cleveland Guardians player during the third inning of the Game. All non-winning Entries roll over for subsequent Games. There's a limit of one Grand Prize Winner for the entire Sweepstakes. For purposes of this Sweepstakes, if

more than one (1) Grand Slam Home Run is hit by a Cleveland Guardians player during the same third inning of a Game, only the *first* Grand Slam Home Run that occurs during that inning will trigger the potential award of a prize. No additional prizes will be awarded if a second or subsequent Grand Slam Home Run is hit in the same third inning of that Game.

- **FIRST PRIZE SELECTION AND NOTIFICATION (AFTER GRAND PRIZE):** Winners need not be present at any Game to win. The First Prize will be awarded only if the Grand Prize is claimed and unavailable. Further, the First Prize will only be available until August 28, 2026. For the avoidance of doubt, even if unawarded, the First Prize will not be available after August 28, 2026. Subject to the foregoing, the First Prize will be awarded if a Cleveland Guardians player hits a Grand Slam Home Run during the third inning of a Game. If these conditions are met, a random Entrant will be selected, and the potential winner will be announced and notified in-stadium and by email/telephone (at Administrator's discretion). No winner will be declared if no Grand Slam Home Run is hit by a Cleveland Guardians player during the third inning of a Game. All non-winning Entries roll over for subsequent Games. Limit: two First Prize Winners for the entire Sweepstakes. Any Game that begins on August 28, 2026, but extends beyond midnight in the time zone where the Game is being played is considered August 28, 2026, for purposes of this Sweepstakes.
- **SECOND PRIZE SELECTION AND NOTIFICATION (AFTER GRAND AND FIRST PRIZES):** Winners need not be present. Before August 28, 2026, the Second Prize will be awarded only if the Grand Prize and First Prizes are claimed and unavailable. For the avoidance of doubt, as of August 28, 2026, provided that the Grand Prize has been claimed and is unavailable, even if the First Prize has not been entirely awarded, the Second Prize may be awarded. Subject to the foregoing, the Second Prize will be awarded if a Cleveland Guardians player hits a Grand Slam Home Run during the third inning of a Game. If these conditions are met, a random Entrant will be selected, and the potential winner will be announced and notified in-stadium and by email/telephone (at Administrator's discretion). No winner will be declared if no Grand Slam Home Run is hit by a Cleveland Guardians player during the third inning of a Game. All non-winning Entries roll over for subsequent Games. Limit: two Second Prize Winners for the entire Sweepstakes. Any Game that begins on August 28, 2026, but extends beyond midnight in the time zone where the Game is being played is considered August 28, 2026, for purposes of this Sweepstakes.

**GRAND SLAM DEFINITION:** An official "**Grand Slam Home Run**" is defined in these Official Rules as an official home run as ruled by Major League Baseball while there are base runners on all three (3) bases – resulting in four (4) runs scoring on the play. The Grand Slam Home Run must be officially ruled as a 4-run home run in the box score and official statistics of Major League Baseball. Inside the park home runs will be eligible to contribute to the winning Grand Slam Home Run provided there are no errors committed on the play, and the hit is officially ruled as a home run.

**WINNER REQUIREMENTS:** The potential Sweepstakes winners will be required to sign and return an Affidavit of Eligibility and Liability Release, and except where prohibited by law, a publicity release form (collectively, the "affidavit/release"). In the event a potential winner does not acknowledge receipt of notification within forty-eight (48) hours of the first notification attempt, or if the potential winner cannot be reached at the telephone number or email address provided on the potential winner's Entry within forty-eight (48) hours of the first notification attempt, the prize may be forfeited and an alternate potential winner may be selected, in Administrator's sole discretion. Any potential winner who timely acknowledges notification must then sign and return the required affidavit/release within five (5) days of such acknowledgment. **CONCLUSION OF PRIZE PORTIONS:** Until the Grand Prize is awarded no other prizes are available. If, prior to August 28, 2026, a Cleveland Guardians player hits a Grand Slam Home Run during the third

inning of a Game the Grand Prize portion of the Sweepstakes shall conclude and the First Prize becomes available. If the Grand Prize and First Prize items are awarded by August 28, 2026, the Second Prize becomes available. Alternatively, if by August 28, 2026, the Grand Prize has been awarded, but the First Prize has not been entirely awarded, the Second Prize becomes available. If all Second Prize items are awarded, the Second Prize portion, and the entire Sweepstakes, concludes. There is only one potential Grand Prize Winner, two potential First Prize Winners, and two potential Second Prize Winners, totaling five potential winners for the entire Sweepstakes.

**NO GRAND SLAM HOME RUN, NO PRIZES:** If no Grand Slam Home Run is hit by a Cleveland Guardians player during the third inning during any Game during the entire Promotional Period, no Grand Prize, First Prize, or Second Prize will be awarded.

**Effect of Rescheduled/Cancelled/Incomplete Designated Games:**

- a. If a Game is cancelled, without being rescheduled, for any reason prior to becoming an Official Game, no prize claims will be acknowledged for that Game, even if a Grand Slam Home Run is hit by a Cleveland Guardians player during the third inning of a Game. A Game shall become an **"Official Game"** once the visiting team has made fifteen (15) outs, and the home team is leading or once the home team has made fifteen (15) outs regardless of score and in each case the statistics are officially recorded by Major League Baseball.
- b. If a Game is rescheduled to a Game date before September 27, 2026, then that Game, as rescheduled, shall be eligible to win under the terms of these Official Rules, assuming the remaining requirements are met. If a Game is rescheduled to a Game date after September 27, 2026, then that Game shall not be eligible to win under the terms of these Official Rules.
- c. Any rain-shortened Game, or any Game that is less than 9-innings, shall be eligible for the potential prize in these Official Rules as long as the Game is considered an Official Game, and the stats of the Game are officially recorded by Major League Baseball.

**PRIZES/ODDS:** There will be potentially one (1) Grand Prize Winner, two (2) First Prize Winners, and two (2) Second Prize Winners.

**GRAND PRIZE:** There will be no more than one (1) Grand Prize awarded during the Sweepstakes.

One winner ("**Grand Prize Winner**") will win a new 2026 Hyundai KONA a maximum MSRP (including freight) of \$35,750.00 (thirty-five thousand seven hundred and fifty dollars) ("**Grand Prize**"). Any difference between the price of the Grand Prize and \$35,750.00 (thirty-five thousand seven hundred and fifty dollars), if any, may be applied towards the corresponding tax, title and license fees; any further difference will be forfeited, and no cash value will be awarded. - Four (4) custom Cleveland Guardians jerseys. First Prize Winners may choose the name and number on the jersey only. All other details shall be determined by Sponsor in Sponsor's sole discretion.
- Four (4) On-Field Experience passes provided by the Cleveland Guardians
  - The exact date and time of the On-Field Experience is based on the Cleveland Guardians' sole discretion. The On-Field Experience must occur no later than the conclusion of the Cleveland Guardians' 2026 regular season and is subject to availability. If the Cleveland Guardians are unable to schedule the On-Field Experience prior to that date, Sponsor reserves the right, in its sole discretion, to substitute an experience of comparable or greater value.
- Two (2) autographed Cleveland Guardians memorabilia item(s) (make, model, size, style, player autograph, and other aspects of memorabilia are determined at the sole discretion of the Sponsor).

The foregoing shall collectively be referred to as the "**First Prize**".

The ARV of the First Prize package is up to \$2,050.00 per winner. The Total ARV for all First Prize packages is up to \$4,100.00. The actual ARV of each First Prize package will vary based upon the specific memorabilia received and may be less than the stated maximum.

**SECOND PRIZE:** There will be no more than two (2) Second Prize winners ("**Second Prize Winner(s)**") who will receive the following prize:

- Four (4) custom Cleveland Guardians jerseys. Second Prize Winners may choose the name and number on the jersey only. All other details shall be determined by Sponsor in Sponsor's sole discretion.
- Four (4) Stadium Tour passes provided by the Cleveland Guardians
  - The exact date and time of the Stadium Tour is based on the Cleveland Guardians' sole discretion. The Stadium Tour must occur no later than the conclusion of the Cleveland

Guardians' 2026 regular season and is subject to availability. If the Cleveland Guardians are unable to schedule the Stadium Tour prior to that date, Sponsor reserves the right, in its sole discretion, to substitute an experience of comparable or greater value.
