

OFFICIAL RULES

NORDSTROM CUSTOMERS - WE APPRECIATE YOU SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE NORDSTROM CUSTOMERS - WE APPRECIATE YOU SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 12:00 AM PACIFIC TIME ("PT") ON FEBRUARY 2, 2026, AND ENDS AT 11:59 PM PT ON FEBRUARY 22, 2026, (THE "SWEEPSTAKES PERIOD"). ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO THOSE WHO ARE LEGAL RESIDENTS AND LOCATED IN ONE OF THE 50 UNITED STATES OR DISTRICT OF COLUMBIA AND ARE AT LEAST 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY (COLLECTIVELY AN "ENTRANT" OR "ENTRANTS"). VOID WHERE PROHIBITED OR RESTRICTED. Employees of Nordstrom, Inc. Entrants must complete and submit the entry form with all required information for the Entry to be eligible. ENTRIES MUST BE SUBMITTED BY 11:59 PM PT ON FEBRUARY 22, 2026. No other methods of entry will be accepted. The Released Parties (defined below) are not responsible for lost, late, illegible, stolen, incomplete, invalid, unreadable, misdirected or unintelligible Entries. Proof of submission will not be deemed proof of receipt by the Sponsor and/or Administrator. By entering, you agree to receive Nordstrom marketing emails. You may unsubscribe at any time, and opting out will not affect your entry or chances of winning.

Online entries are hereinafter referred to as "Entry" or "Entries."

LIMIT: THERE IS A LIMIT OF ONE (1) ENTRY PER PERSON FOR THE ENTIRE SWEEPSTAKES. In the event of a dispute as to any Entry based on email address, the authorized account holder of the email address used to register will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Any potential winner may be required to show proof of being the authorized account holder. No mechanical reproductions of entry forms permitted. Any attempt by any participant to obtain more than the stated number of Entries by using multiple/different identities, registrations or any other methods will void that participant's Entries, and that participant may be disqualified. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unreadable, misdirected or unintelligible Entries, which will be disqualified. Administrator will not accept submissions from wireless domains, blacklist domains, or any email address Administrator deems to be potentially harmful to the Website. WINNER SELECTION: Administrator will randomly select one hundred twenty-five (125) potential prize winners (the "Potential Winners") in a random drawing conducted on or about February 24, 2026, from among all eligible Entries received during the Sweepstakes Period. obligation.
