

# OFFICIAL RULES NORDSTROM RACK NORDY CLUB MEMBER SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

THE NORDSTROM RACK NORDY CLUB MEMBER SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 12:00 AM MOUNTAIN TIME ("MT") ON JUNE 1, 2026, AND ENDS AT 11:59 PM MT ON JUNE 30, 2026, (THE "SWEEPSTAKES PERIOD"). FOR PURPOSES OF DETERMINING THE TIMELINESS OF AN IN-STORE ENTRY, SPONSOR'S POINT-OF-SALE SYSTEM AT THE APPLICABLE PARTICIPATING STORE WILL BE THE OFFICIAL TIME-KEEPING DEVICE. FOR PURPOSES OF DETERMINING THE TIMELINESS OF A MAIL-IN ENTRY, THE UNITED STATES POSTAL SERVICE POSTMARK ON THE OUTER MAILING ENVELOPE WILL CONTROL.

**ELIGIBILITY:** THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE STATE OF COLORADO WHO ARE MEMBERS OF NORDSTROM'S NORDY CLUB PROGRAM ("NORDY CLUB") AND ARE AT LEAST 18 YEARS OF AGE AT TIME OF ENTRY (COLLECTIVELY AN "ENTRANT" OR "ENTRANTS"). VOID WHERE PROHIBITED OR RESTRICTED. Joining the Nordy Club is free and may be done by visiting [www.nordstrom.com/browse/nordy-club](http://www.nordstrom.com/browse/nordy-club) or going to a Nordstrom Rack store and signing up with a salesperson. Employees, officers, directors, representatives, and agents of Nordstrom, Inc. d/b/a Nordstrom Rack ("Sponsor"), EventLink Group ("Administrator"), and their respective parent companies, affiliates, subsidiaries, advertising, promotion, fulfillment, and judging agencies, prize suppliers, and any other entities involved in the development, administration, promotion, or fulfillment of the Sweepstakes, and members of their immediate families (spouses, children/dependents and their spouses, and in-laws), and people living in the same household with such individuals (whether related or not) are not eligible to enter or win.

**AGREEMENT TO THE OFFICIAL RULES:** By participating, Entrants agree to be bound by these Official Rules and the decisions of the Administrator and/or Sponsor, which are binding and final on matters relating to this Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**HOW TO ENTER:** There are two (2) ways to enter the Sweepstakes during the Sweepstakes Period:

**IN-STORE ENTRY:** Nordy Club members who make an in-store purchase, return, or exchange (each a "Transaction") during the Sweepstakes Period at a Participating Store listed below during store hours of operation, and who, at the time of the Transaction, either complete the Transaction using a Nordstrom-branded credit or debit card linked to their Nordy Club account or provide the phone number and/or email address linked to their Nordy Club account to the cashier, will receive one (1) Entry into the Sweepstakes.. ALL IN-STORE ENTRIES MUST BE COMPLETED BY 11:59 PM MT ON JUNE 30, 2026. LIMIT: one (1) In-Store Entry per person, per day, per store, per each transaction type, subject to the overall limit of five (5) Entries per person for the entire Sweepstakes Period, regardless of method of entry.

**MAIL-IN ENTRY:** Alternatively, Entrants can enter the Sweepstakes during the Sweepstakes Period without making an in-store purchase, return, or exchange, by legibly hand printing their name on a plain piece of 3" x 5" paper, including their first and last name, complete street address (no P.O. boxes), city, state, including zip code, and phone number linked to the Entrant's Nordy Club account and, if the Entrant has an email address associated with his or her Nordy Club account, that email address, and mail it in an envelope with first class postage affixed to: "NORDSTROM RACK NORDY CLUB MEMBER SWEEPSTAKES", c/o EventLink Group, PO Box 249, Spring Hill, TN 37174. ("Mail-In" entry). The email address is requested to facilitate Notification, and its omission will not, standing alone, disqualify an otherwise complete and timely Mail-In Entry. No mechanically reproduced entries will be accepted. No metered mail will be accepted. Limit one (1) Mail-In Entry per postmarked outer mailing envelope.

An Entrant may submit multiple Mail-In Entries, provided each Mail-In Entry is mailed separately and the Entrant does not exceed the overall limit of five (5) Entries per person for the entire Sweepstakes Period, regardless of method of entry. ALL MAIL-IN ENTRIES MUST BE POST-MARKED BY JUNE 30, 2026, AND RECEIVED BY JULY 6, 2026. Illegible or incomplete Mail-in Entries are void.

In-Store and Mail-In entries are hereinafter referred to as "Entry" or "Entries."

**LIMIT:** THERE IS A LIMIT OF FIVE (5) ENTRIES PER PERSON FOR THE ENTIRE SWEEPSTAKES PERIOD, REGARDLESS OF METHOD OF ENTRY OR COMBINATION OF METHODS OF ENTRY. In the event of a dispute regarding the identity of an Entrant, the Entry will be deemed submitted by the Nordy Club account holder of record associated with the phone number or Nordy Club credential used at the time of the Transaction, or, in the case of a Mail-In Entry, by the individual whose name and contact information are legibly hand-printed on the Mail-In Entry submission. Any Potential Winner may be required to provide proof of his or her identity and ownership of the Nordy Club account to the reasonable satisfaction of Administrator and Sponsor.. No mechanical reproductions of entry forms permitted. Any attempt by any participant to obtain more than the stated number of Entries by using multiple/different identities, registrations or any other methods will void that participant's Entries, and that participant may be disqualified. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unreadable, misdirected or unintelligible Entries, which will be disqualified. Administrator reserves the right to disqualify any Entry that appears to be fraudulent, incomplete, invalid, or submitted in violation of these Official Rules. Use of any automated system to participate is prohibited and will result in disqualification. All Entries become the property of Sponsor and/or Administrator and will not be acknowledged or returned. Please also see the "Entrant's Personal Information" section below, of these Official Rules.

**WINNER SELECTION:** Administrator will randomly select five (5) potential prize winners (the "Potential Winners") in a random drawing conducted on or about July 21, 2026, from among all eligible Entries received during the Sweepstakes Period. Potential Winners will be notified by phone and/or email using the contact information associated with the Potential Winner's Nordy Club account or otherwise provided at the time of Entry, in order to be verified as eligible and confirmed as a winner (the "Notification"). **Potential Winners will be required to respond to the Notification within forty-eight (48) hours.** If any Potential Winner cannot be contacted, fails to respond within the time allotted, fails to execute and return required documents within the specified time, is found to be ineligible, or otherwise fails to comply with these Official Rules, that Potential Winner will be disqualified and an alternate Potential Winner may be selected in a random drawing from among all remaining eligible Entries. Sponsor is not responsible for suspended or discontinued wireless service which may result in a Potential Winner not receiving the Notification. Potential Winner will be required to complete, sign and return an affidavit of eligibility and liability and, except where prohibited, a publicity release within five (5) business days to officially secure the prize. If any Potential Winner's Notification is rejected, returned, or deemed undeliverable or any Potential Winner

fails to execute and return the affidavit/release(s) within the specified time, or if he/she is otherwise ineligible to receive the prize, even if the disqualified Potential Winner's name may have been publicly announced, that Potential Winner will be deemed ineligible and the prize will be awarded to an alternate Potential Winner selected at an alternate random drawing from all remaining eligible Entries. Subject to verification of eligibility and compliance with these Official Rules, any Potential Winner will be declared an official Prize Winner of the Sweepstakes (the "Prize Winner"). **PRIZE/ODDS:** Five (5) Prize Winners will each receive one (1) prize consisting of one (1) \$500 Nordstrom promotional award card. The promotional award card is issued as a sweepstakes prize and is not a purchased gift card. If Sponsor or Administrator elects to abbreviate the Sweepstakes as a result of a Force Majeure event, Sponsor and/or Administrator reserves the right to award the prizes from among all eligible Entries received up to the date of such Force Majeure event. Sponsor and Administrator also reserve the right, in their sole discretion, to cancel, modify, or suspend the Sweepstakes in whole or in part, in the event of fraud, technical or other difficulties, or if the integrity of the Sweepstakes is compromised, without liability to any Entrant.
