

OFFICIAL RULES

OKLAHOMA CHEVY TEAM DEALERS OKANA SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE OKLAHOMA CHEVY TEAM DEALERS OKANA SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 12:00 A.M. EASTERN TIME ("ET") ON JUNE 19, 2026, AND ENDS ON DECEMBER 31, 2026, AT 11:59 P.M. ET (THE "PROMOTIONAL PERIOD"). THE ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

AGREEMENT TO THE OFFICIAL RULES: By participating, Entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which are binding and final on matters relating to this Sweepstakes. VIA ON-SITE EVENTS: Eligible entrants may also enter by completing and submitting an official entry form, as directed, at the Chevrolet display area at selected Chevrolet promotional events at which Chevrolet Brand Ambassadors are present during posted hours of operation. On-site events, locations, dates, hours, and Chevrolet display availability are subject to change or cancellation. No purchase from Sponsor, any Chevrolet dealership, General Motors LLC, OKANA Resort & Indoor Waterpark, or any other entity is required to enter or win. Entrants are not required to attend any on-site event to enter and may enter for free via the Website during the Promotional Period.

Entrants will be required to provide first name, last name, mailing address, phone number, and email address in order to enter the Sweepstakes. Entrants may also be given the option to provide purchase horizon and vehicle interest information; however, providing such optional information is not required to enter the Sweepstakes and will not affect eligibility or an Entrant's chances of winning.

Website and On-site entries are hereinafter referred to as "Entry" or "Entries."

LIMIT: THERE IS A LIMIT OF ONE ENTRY PER PERSON, PER EMAIL ADDRESS, FOR THE ENTIRE SWEEPSTAKES, REGARDLESS OF METHOD OF ENTRY. WINNER SELECTION: Administrator will randomly select one (1) potential Grand Prize Winner (the "Potential Grand Prize Winner") in a random drawing conducted on or about January 4, 2027, from among all eligible Entries received during the Promotional Period. Potential Grand Prize Winner will be notified by phone or email and will be required to respond to the notification within seventy-two (72) hours from initial contact indicating whether he/she can accept the prize. If no response is received within the time allotted, an alternate potential winner will be selected in a random drawing from among all remaining eligible Entries.
