

OFFICIAL RULES NORDSTROM PARTY FAVOR SCRATCH & WIN SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE NORDSTROM PARTY FAVOR SCRATCH & WIN SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 12:00 A.M. PACIFIC TIME ("PT") ON JULY 14, 2026, AND ENDS AT 11:59 P.M. PT ON AUGUST 28, 2026, (THE "OVERALL PROMOTION PERIOD"). THE SWEEPSTAKES IS COMPRISED OF THREE DEFINED PHASES WITHIN THE OVERALL PROMOTION PERIOD: (I) THE "DISTRIBUTION PERIOD," BEGINNING AT 12:00 A.M. PT ON JULY 14, 2026, AND ENDING AT 11:59 P.M. PT ON JULY 17, 2026, DURING WHICH SCRATCH-OFF TICKETS WILL BE DISTRIBUTED; (II) THE "REDEMPTION PERIOD," BEGINNING ON JULY 18, 2026, AND ENDING AT 11:59 P.M. PT ON AUGUST 9, 2026, DURING WHICH WINNING SCRATCH-OFF TICKETS MUST BE REDEEMED; AND (III) THE "SECOND CHANCE DRAWING ENTRY PERIOD," BEGINNING AT 12:00 A.M. PT ON AUGUST 10, 2026, AND ENDING AT 11:59 P.M. PT ON AUGUST 28, 2026, DURING WHICH ENTRIES MAY BE SUBMITTED FOR THE SECOND CHANCE DRAWING. ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO THOSE WHO ARE LEGAL RESIDENTS AND LOCATED IN ONE OF THE 50 UNITED STATES OR DISTRICT OF COLUMBIA AND ARE AT LEAST 18 YEARS OF AGE OR OLDER AT TIME OF ENTRY (COLLECTIVELY AN "ENTRANT" OR "ENTRANTS"). VOID WHERE PROHIBITED OR RESTRICTED. Employees of Nordstrom, Inc. ("Sponsor"), EventLink Group ("Administrator"), and their respective employees, volunteers, directors, parents, affiliates, subsidiaries, and their advertising and Sweepstakes agencies, and the members of their immediate families (spouses and parents, siblings, children and their spouses and in-laws), and persons living in the same household with such individuals (whether related or not) are not eligible to enter or win.

AGREEMENT TO THE OFFICIAL RULES: By participating, Entrants agree to be bound by these Official Rules and the decisions of the Administrator and/or Sponsor, which are binding and final on matters relating to this Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws. Winning a prize is contingent upon fulfilling all requirements set forth herein.

HOW TO ENTER: There are two free ways to secure a Scratch-Off Ticket, each offering the same chance of winning. All Scratch-Off Tickets, whether obtained in store or by the Alternate Method of Entry ("AMOE"), are awarded subject to the "Limit" paragraph below and to the stated daily or online inventory.

IN-STORE DISTRIBUTION: Beginning when each participating Nordstrom store opens on every day of the Distribution Period, up to two hundred and fifty (250) Scratch-Off Tickets will be handed out per store, per day, while supplies last, provided that no store will distribute more than one thousand (1,000) Scratch-Off Tickets in total during the Distribution Period or continue distribution once its four-day allotment is exhausted. A list of participating Nordstrom stores is available at www.nordstromrsvp.com/anniversary, or by written request to Administrator at the address set forth below. No purchase or payment is required. Distribution at a given store ends for the day when either the 250-ticket allotment is exhausted or the store closes, whichever occurs first.

ONLINE ALTERNATIVE METHOD OF ENTRY (AMOE): Without visiting a store, an eligible person may, during the Distribution Period, go to www.nordstromrsvp.com/anniversary, complete the entry form with all required information, and submit it as directed. Sponsor has earmarked an exact online inventory of seven thousand (7,000) Scratch-Off Tickets, the balance of the one hundred thousand (100,000) tickets not allocated to stores. Tickets are awarded in the order valid AMOE submissions are received until the online inventory is depleted or until 11:59 p.m. PT on July 17, 2026, whichever occurs first. Each valid AMOE entrant will have one Scratch-Off Ticket mailed to the street address supplied at time of entry. Incomplete, inaccurate, or duplicate submissions are void. By entering, you agree to receive Nordstrom marketing emails. Opting out to receive marketing emails will not affect entry or chances of winning. Entrants who opt in may unsubscribe at any time in accordance with applicable law.

Mail-Delivery Allowance for AMOE Redemption. To account for normal mail-delivery times for AMOE entrants who receive Scratch-Off Tickets by mail, AMOE entrants electing to redeem by mail must postmark their redemption by August 16, 2026, and the mailed redemption must be received by Administrator by August 20, 2026 (in lieu of the August 9, 2026, postmark and August 13, 2026, receipt deadlines that apply to Scratch-Off Tickets obtained in store). AMOE entrants may alternatively elect to redeem in person at a participating Nordstrom store during the Redemption Period.

LIMIT: Regardless of method, each person may obtain only one (1) Scratch-Off Ticket per calendar day, for a maximum of four (4) during the Distribution Period. Attempts to exceed this limit—whether by using multiple identities, e-mail addresses, telephone numbers, or any other device—will void all of that person's tickets and may result in disqualification. No mechanical reproduction of entry forms permitted. Any attempt by any participant to obtain more than the stated number of entries by using multiple/different identities, registrations, or any other methods will void that participant's entries and that participant may be disqualified. Administrator and/or Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, unreadable, or misdirected entries, which will be disqualified. All entries become the property of Sponsor and/or Administrator and will not be acknowledged or returned. Please also see the "Entrant's Personal Information" section below.

Total Ticket Cap. Sponsor will print and distribute no more than 100,000 Scratch-Off Tickets in the aggregate across all entry methods and participating locations. Once all Scratch-Off Tickets have been distributed, no further tickets will be available, and the Sweepstakes will be closed to additional entries.

PRIZE SELECTION AND REDEMPTION: Potential winners will receive a Scratch-Off Ticket either at a participating Nordstrom Store or via online entry. To redeem a winning ticket, winners have two options:

a. **In-Store Redemption:** During the Redemption Period, winners may enter a participating Nordstrom Store and redeem the Scratch-Off Ticket for a physical Nordstrom Gift Card or Nordstrom Promotional Card, as indicated on the Scratch-Off Ticket. The card value will be indicated on the Scratch-Off Ticket.

b. **Mail-In Redemption:** Winners must complete and sign the front of the Scratch-Off Ticket, keep a copy, and mail the original ticket in a stamped envelope addressed to Administrator, postmarked during the Redemption Period, and received by August 13, 2026, to: NORDSTROM PARTY FAVOR SCRATCH & WIN SWEEPSTAKES REDEMPTION, c/o EventLink Group, PO Box 249, Spring Hill, TN 37174. AMOE entrants electing to redeem by mail are subject to the extended deadlines set forth in the Mail-Delivery Allowance paragraph above. Digital Nordstrom Gift Cards or Nordstrom Promotional Cards will be e-mailed to recipients within fourteen (14) business days of Administrator's receipt of the redeemed Scratch-Off Ticket.

PRIZE/ODDS: The prizes available in the Sweepstakes are as follows:

GRAND PRIZE: There will be no more than one (1) Grand Prize Winner that consists of a \$2,000.00 Nordstrom Store Gift Card. The total Approximate Retail Value ("ARV") of the Grand Prize is: \$2,000.00.

RUNNER UP PRIZES: There will be no more than ninety-nine thousand nine hundred ninety-nine (99,999) Runner Up prizes as set forth in the table below.

The total ARV of all Runner Up Prizes is \$540,825.00. The total ARV of all prizes in the Sweepstakes is \$542,825.00.

Prize Seeding. All prize values were randomly seeded on Scratch-Off Tickets under independent supervision before any tickets were sent to stores or allocated to the AMOE pool. All Scratch-Off Tickets are randomly allocated from one master seeded prize pool, and no prize tier, including the Grand Prize, is excluded from the AMOE pool. Because ticket bundles are randomly assembled for participating stores and for the AMOE pool, each bundle may contain a different mix of prize tiers, but the print run as a whole reflects the prize quantities set forth in the table above. The order in which tickets are distributed does not reveal—and cannot affect—the prize printed on any individual ticket. Any prize-bearing Scratch-Off Ticket that is not distributed during the Distribution Period (whether because a store's inventory is not exhausted or because the AMOE inventory is not exhausted) will be deemed an unawarded prize and will be reconciled into the Second Chance Drawing prize pool described below.

Odds: Every Scratch-Off Ticket distributed will reveal a prize. Because prize values are pre-seeded across the entire 100,000-ticket print run, the odds of obtaining a Scratch-Off Ticket bearing a particular prize tier, assuming all 100,000 tickets are distributed across both entry methods combined, are approximately as follows: \$2,000 Grand Prize Gift Card — 1 in 100,000; \$500 Gift Card — 1 in 25,000; \$125 Gift Card — 1 in 800; \$100 Gift Card — 1 in 2,000; \$50 Gift Card — 1 in 556; \$20 Gift Card — 1 in 250; \$10 Gift Card — 1 in 100; and \$5 Promotional Card — approximately 98,240 in 100,000 (or 98.24%). If fewer than 100,000 Scratch-Off Tickets are distributed during the Distribution Period, any prize-bearing Scratch-Off Tickets that were not distributed will be reconciled into the Second Chance Drawing prize pool, as described below. In the Sponsor's sole discretion, a potential winner may be required to forfeit a prize if the selected potential winner (i) declines or cannot accept, receive, or use the prize for any reason; or (ii) fails to comply with these Official Rules. The maximum value of the prizes set forth above represents the Sponsor's good faith determination of the maximum ARV thereof, and the actual fair market value, as ultimately determined by the Sponsor and Administrator, cannot be challenged or appealed.

For purposes of identifying the Second Chance Drawing prize pool, on or about August 21, 2026, (following the receipt deadline for AMOE mail-in redemptions), Administrator will reconcile (a) all prize-bearing Scratch-Off Tickets that were not distributed during the Distribution Period and (b) all prize-bearing Scratch-Off Tickets that were distributed but not redeemed by the applicable redemption deadline. The aggregate of those unawarded and unclaimed prizes will constitute the Second Chance Drawing prize pool.
